ARTICLE 4: MEMBERSHIP

(a) Regular Members

- (i) All the officers of the subsidiary companies of erstwhile MPSEB posted in Jabalpur and all the officers of the State Govt. Central Govt. on deputation to aforesaid companies and posted at Jabalpur shall be eligible to become a regular Member of the Club on payment of prescribed admission and monthly fees.
- (ii) The retired officers of the aforesaid companies stated at Jabalpur shall also be eligible to become regular Members of the club on payment of prescribed admission and monthly fee after prior approval of the governing body.

(b) Associate Members

All the officers of the Central/State Govt. and Doctors, whether in service or retired residing in MPSEB Complex, Vidyut Nagar, Jabalpur shall be eligible for becoming Associate Members of the Club provided their application for admission is recommended by two regular Members and the same is approved by the Governing Body. They shall also be liable for the prescribed admission and monthly subscription. They will, however, have no right for voting.

(c) Special Members

The Governing Body with the prior approval of the patron may permit any person to become a special member of the Club. Special Members will, however, have no right of voting.

ARTICLE 5: ADMISSION AND MONTHLY SUBSCRIPTION

(a) Admission fee and monthly subscription:-

- (i) For regular Members will be paid Rs.500/- & Rs.200/- respectively.
- (ii) For Associate Members will be paid Rs.7500/- & Rs.1000/- respectively.
- (iii)For Special Members will be paid Rs.15,000/- & Rs.2000/-.

(b) Mode of payment:-

- (i) The recovery of Club fee subscription and any other amount due towards the regular Members shall be affect4ed from the Salary bills/pension, as the case may be. All the Members shall give their written consent for the same.
- (ii) The Associate Members and Special Members will be required to pay the monthly subscription of Rs.1000/- & Rs.2000/- in cash before the expiry of 5th day of each calendar month in advance.
